

Please indicate your interest for participation in these exhibitions by filling up and returning the attached application form duly filled and signed alongwith the necessary deposits as per your space requirement, per exhibition (clearly indicating which exhibition the payment is made for) as "on account payment" in favour of The Gem & Jewellery Export Promotion Council latest by November 30, 2009.

You are requested to carefully go through the terms & conditions for participation and cancellation as described overleaf of the Space Application form, before submitting the application. Under no circumstance, whatsoever, any concession to / compromise with the terms & conditions and / or rules pertaining to CANCELLATION shall be entertained after one applies for the participation in the exhibition in prescribed format and / or in writing through any means whatsoever.

The Council would screen the applications as per the norms of selection set up and the members thus selected for each exhibition will be informed in due course. The decision of the Council in selection of exhibitors for any of the shows is final and binding.
