FDI Inflows in Indian Gem and Jewellery Sector

April -September 2022

- 1. Total FDI Equity inflows in India declined by (-) 14 % to US\$ 26.91 billion in April -September 2022
 - According to the DPPIIT Data, the total FDI equity inflows in India declined by (-) 14 % to US\$ 26.91 billion in April -September 2022 from US\$ 31.15 billion recorded in same period last year (Table-1)
 - Overall, the total FDI equity inflows in India have almost doubled from US\$ 29.7 billion in 2014-2015 to US\$ 58.77 billion in 2021-2022 (**Table-1**)
- 2. Total FDI Equity inflows in Indian G&J Sector grew by around 61 % to US\$ 22.22 million during 2021-2022 in comparison to last year (Table-1)
- 3. Total FDI Equity Inflows in Indian G&J Sector in India in April -September 2022 declined marginally by (-) 0.29 % to US\$ 6.84 million as compared to US\$ 6.86 million recorded in April -September 2021 (Table-1)

4. Share of G&J Sector in Total FDI Equity Inflows in India stood at 0.02 % in April - September 2022

The Share of FDI in the Gems and Jewellery sector has been declining since 2014-2015 and has contracted from 0.88 % in 2014-2015 to 0.04 % in 2021-2022 (Table-2). However, the share of FDI in G&J sector had risen from 0.02 % in 2020-2021 to 0.04 % in 2021-2022 .

Currently ,the FDI in the G&J sector is recorded at US\$ 6.84 million during April -September 2022 , comprising around 0.02 % of India's total FDI of US\$ 26.91 billion received during the said period. (Figure -1 and Table -2)
