- The Council reserves the right to reject any Application Form submitted by the Applicant for the Event, without assigning any reason whatsoever and every such decision of the Council shall be final.
- An Application Form which is not accompanied with the full Registration Fees, pursuant to the applicable category, shall be rejected.
- The Council reserves the right to temporarily or permanently suspend entry of any Applicant to any of conference(s) forming part of the Event for security reason as may be deemed reasonable and necessary.
- Not more than 3 delegates can be registered from a company.
- Only 50 students will be registered on first come first basis.
- Entry is strictly prohibited for minors (i.e., below 18 year of age), except for those who are students and pursuing courses with Institutes as referred above. Every such students will be required to carry with them, at all times during Mines to Market, a valid Student Photo Identification Card of the Institute, a certified copy of which has been submitted by them at time of applying for registration.

The entire payment in form of Cash will be accepted provided the same is paid in person at the above address. The Council shall not be responsible for any payment made in form of Cash through Courier. For the avoidance of doubt, it is agreed that any Courier containing cash payment shall not be accepted by the Council.
