DEFINITION: 'Application' means and includes Application Form and Standard Terms & Conditions mentioned herein.

'Applicant' means and includes a firm / company / entity applying for seeking participation at TJF scheduled to be held from _____ to _____.

'Council' or 'the Council' or 'GJEPC' means the Gem & Jewellery Export Promotion Council of India and includes the committees of the Council & its members, executives, employees, directors, officers, contractors, sub-contractors and agents.

'TJF' or 'Seminar' or "Workshop" means the Trend Jewellery Forecasting Seminar 2011, which also includes a workshop organized by the Council under the name Trend Jewellery Forecasting Seminar 2011. For the avoidance of doubt, the word Seminar includes Workshop and vice-versa. Sometimes, TJF is used to mean and include Seminar & Workshop.
