## Terms & Conditions

- 1. The Council reserves the right to reject any Application Form submitted by the Applicant for the Event, without assigning any reason whatsoever and every such decision of the Council shall be final.
- 2. An Application Form which is not accompanied with the full Registration Fees, pursuant to the applicable category, shall be rejected.
- 3. The Council reserves the right to temporarily or permanently suspend entry of any Applicant to any of conference(s) forming part of the Event for security reason as may be deemed reasonable and necessary.
- 4. Entry is strictly prohibited for minors (i.e., below 18 year of age).
- 5. All Payments as referred to herein should be made by Cheque / Demand Draft, payable at par, drawn in favour of 'The Gem & Jewellery Export Promotion Council' along with this Application Form and should be submitted either in person or through courier at the Council's Head Office located at **AW 1010, Tower A, G Block, Bharat Diamond Bourse, Next to ICICI Bank,**Bandra-Kurla Complex, Bandra East, Mumbai 400 051, India. The entire payment in form of Cash will be accepted provided the same is paid in person at Council's HO. The Council shall not

The Council shall not be responsible for any payment made in form of Cash through Courier. For the avoidance of doubt, it is agreed that any Courier containing cash payment shall not be accepted by the Council. Any claim in this behalf, despite the Council's clear indication that Cash shall not accepted if sent through courier, shall not be entertained by the Council.

- 6. The Applicant shall not be allowed to record any conference(s) forming part of the Event, whether in part or in full and if any such recordings come to knowledge of the Council, in such cases the Council shall be free to confiscate every such recordings and the equipments used for such recordings.
- 7. In case of misuse/impersonation of badge(s) by the Applicant, such misused badge will be confiscated and no new badge will be issued in lieu of such confiscated badge(s). In addition to such confiscation of the badge the Applicant will be duly cautioned in writing for such violation and misuse of badge.
- 8. Each participant Applicant is liable for its own security and any & all of its belongings. The Council shall not be responsible in any manner whatsoever for whatever security measurements that may be needed to be taken care of by the participant Applicant during the Event. Any claims of the participant Applicant in this behalf shall not be entertained by the Council on any grounds whatsoever.
- 9. In case any Applicant cancels its participation or is unable to attend the Event for any reasons whatsoever, no refund of fee will be made to the Applicant and the entire payment shall stand forfeited in favour of the Council.
- 10. The Council reserves all rights to cancel the Event at any time for the reasons beyond its control. However, the Council shall not be under an obligation to assign the reason for cancellation of the event. In such a case, upon the Applicant producing the original receipt evidencing payment of participation fees, within 15 days of the announcement of such cancellation, the Council shall refund the actually paid amount without any interest of any nature.
- 11. Likewise, the Council reserves the right to cancel the Event partly without assigning any reason for such cancellation. In such a case the Council shall not make any refund of any amount or payment of any kind whatsoever to any of the participants.
- 12. Force Majeure: The Council shall not be responsible for any failure to perform its obligation as contemplated herein due to unforeseen circumstances or due to causes beyond its control even after exertion of commercially reasonable efforts to prevent such failure, which failure may include, but not be limited to, act of God, fire or floods, war, riots, embargoes, strikes, lockouts, acts of any Government authority, delays in obtaining licenses or rejection of applications under the statutes.
- 13. The Applicant agrees to indemnify and keep the Council indemnified, safe and harmless, on demand, from and against, all and any actions, claims, demands, losses (including consequential losses), proceedings, damages, liabilities, costs and expenses incurred by or made against the Council arising out of (a) breach of any of the Terms & Conditions, Rules and Regulations governing the Applicant's participation in the Event, whether expressly specified here or not, or any applicable laws and regulations, by the Applicant or (b) any act, omission, default or negligence of or loss or damage caused by the Applicant in connection with any other person, the Event and the Event venue.
- 14. It is hereby agreed by and between the Parties hereto that in the event of any dispute or difference arising between the Parties with regard to the terms and conditions herein or relating to the interpretation thereof and or the implementation of respective rights obligations and / or responsibilities of the Parties hereto, the same shall be referred to arbitration, in accordance with the provisions of the Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment thereof for the time being in force. The Arbitral Tribunal shall comprise of a Sole Arbitrator who shall be the Chairman of the Council. The arbitration shall be held in Mumbai and the proceedings shall be conducted in the English language. The parties further agree that only the courts at Mumbai shall have jurisdiction in all matters arising there under.
- 15. The Council reserves the right to amend the rules and regulations of participation from time to time in the best interest of the participant Applicant.
- 16. To the fullest extent permitted by the applicable laws the Council shall not be liable for any direct, indirect, special, consequential, or incidental damages (including but not limited to damages for loss of business profits, business interruption, loss of business information, and the like) arising out of the terms and conditions referred to herein, any documents referenced herein or any addenda or amendment hereto.
