USTR -Proposed Action in Section 301 Investigation of India's Digital Services Tax and Possible Adverse Impact on Indian Gem and Jewellery Sector

1. USTR Proposed Action in Section 301 – Background & Overview

India has adopted a Digital Sales Tax (2% equalisation levy) on revenue generated from a broad range of digital services offered in India, including digital platform services, digital content sales, digital sales of a company's own goods, data-related services, software-as-service and other categories of digital services. India's DST only applies to "non-resident" companies.

On June 2, 2020, USTR initiated an investigation of India's Digital Sales Tax(DST) pertaining to discrimination against US Companies; retroactivity, and possibly unreasonable tax policy. Report about DST India -

On January 6, 2021, based on the information obtained during the investigation and the advice of the Section-301 committee, USTR determined that India's DST is unreasonable or discriminatory and burdens or restricts US Commerce. Section 301 authorizes the USTR to impose duties on the goods of the foreign country subject to investigation.

As per this, USA has proposed retaliatory tariffs up to 25% on select Indian products including Gem & Jewellery for 2% equalization levy being levied by the Indian Government that would collect duties on goods of India in the range of the amount of DST that India is expected to collect from U.S. companies. Initial estimates indicate that the value of the DST payable by U.S.-based company groups to India will be up to approximately \$55 million per year.USTR further proposes that the goods of India subject to additional tariffs would be drawn from the preliminary list of products in the Annex to the notice, as specified by the listed eight-digit tariff subheadings.

We understand that the USTR has proposed such stringent action after conducting a detailed investigation in response to imposition of 2% Digital Services Tax (DST) which states that the DST is discriminatory because it applies only to non-Indian digital services providers and targets digital services, but not similar services provided non-digitally and so on.

At the same time from India's perspective, the GJEPC understands that Indian digital services providers are already subject to tax in India and framing international taxation laws for digital economy as multilateral solution at the level of OECD has prolonged which must have resulted in adopting DST as an interim measure to cope with taxing the offshore digital service providers.

Under Section -301, the USTR has listed specific products to be subjected to increased duties, including whether the tariff subheading listed should be retained or removed or whether tariff subheading not currently on the list should be added.

2. USTR Section 301 and Adverse Impact on Indian G&J Sector

Seventeen (17) Gem & Jewellery products are in the proposed list of products subject to have increase duties under section -301. It is to mention that the 17 products are related to Chapter-71-Gems and Jewellery (Refer Table-1) which are in the list of total 42 proposed products subject to attract duties so as to offset the amount of duties collected by India from US non-resident digital companies.

3. USTR Proposed Action and another Setback to India Gem and Jewellery Sector

USA is India's major export market for gem and jewellery products. Exports of around US\$9.3 billion goes to the USA market accounting for 25.6% of the total gem and jewellery exports of US\$36 billion from the country.

It is to strongly mention that if the proposed action in terms of raising tariff rates on the import of the above stated gem and jewellery products get implemented (after the hearing process which is going to end in May 2021) this would adversely impact gem and jewellery exports of around US\$46 million to US\$53 million and be an another set-back to one of the most labour-oriented and export sector of the country.

Prior to this, over the last decade due to the stringent policy changes by the USA Government towards Indian gem and jewellery sector in the following terms: the sector has already been facing its repercussions in a way of:

- a) declined exports of the key jewellery products
- b) declined % share in USA imports of gem and jewellery products
- c) Shift of India's businesses to its competitors including Turkey, Thailand, Singapore etc.

3.1 Exclusion of key gem and jewellery export commodities from GSP benefit by USA between 2007-2009

Eventual withdrawal of GSP benefit for the key jewellery products in the year 2007, 2008 and 2009 resulted attraction of MFN rate of around 5-6% at the USA customs territories and decline in exports of the various following high-volume jewellery exports from India.

- Articles of gold jewellery (HS Code 71131950)
- Gold rope necklaces and neck chains (HS code 71131921)
- Gold necklace and neck chains (HS code 71131929)
- Gold mixed links, necklaces and neck chains (HS code 71131925)
- Silver articles of jewellery and parts (HS code 71131150)

3.2 Withdrawal of BDC Status for India /Complete withdrawal of GSP Benefit w.e.f July 2019

After the termination of GSP designation of India by USA, exports of around 45 gem and jewellery commodities at HS code 8-digit level which were under the GSP-A and A*category¹ i.e. Duty-Free benefit for Beneficiary Developing Country (BDC) have started attracting the import duties in USA. Consequently, 45 gem and jewellery commodities for which GSP benefit was available in USA had terminated after the complete withdrawal of GSP benefit for India as a whole resulting in terms of escalated prices and reduced export competitiveness of these products.

3.3 Adverse Imapct on Indian Gem and Jewellery Sector

Above stringent measures undertaken by the USA Government in different phases have adversely impacted Indian gem and jewellery sector in the following forms:

a) Declined exports of the key jewellery products after 2007/2009

In total, imports of USA of the above products from India declined by US\$694.14 million (-28%) to US\$1793.61 million in 2019 from US\$2487.75 million in 2007/2009 (**Table-3**).

Declined exports of the 45 commodities after complete withdrawal of BDC status

This has been observed that 45 gem and jewellery commodities which have started attracting duties after the withdrawal of BDC status from India, its declined by around US\$11 million (-13%) to US\$75.34 million in 2019 from US\$86.54 million in 2018 i.e. in less than one year of such change. (Annexure -A)

b) Declined % share in USA imports of gem and jewellery products

It is due to several reasons including change in USA trade policy for Indian gem and jewellery products, India's share in USA has recorded a continuous fall from peak level of 19.96% in 2018 to historically low at 8.66%. It is indicating towards reduced presence of Indian G&J products in USA market (**Table-4**).

c) Shift of India's businesses to its competitors including China, Turkey, Thailand, Singapore etc.

USA imports from India have recorded a decline of US\$1807.43 million (-16.05%) to US\$9450.15 million in 2020 from US\$11257.43 million in 2019. While, its imports from other countries including India's competitor like Singapore, Colombia, South Korea, Turkey, Indonesia etc. have witnessed a significant/unusual rise (**Table-5**).

3.4 Proposed imposition of tariffs on gem and jewellery 17 products – a grave concern

Proposed action of imposing additional tariffs on gem and jewellery products due to the lack of international taxation mechanism for digital economy is going to further dent its exports to the USA market which is really a grave concern for the overall gem and jewellery sector.

Based on the past/recent trends, this is also apparent that eventually India may further lose its % share in USA imports of G&J products from the World and also it can enhance souring of its products from our competitors.

Overall, there will be a lose of exports/business to the sector, employment to the people and foreign exchange to the government (US\$2 billion have been lost in 2020, despite USA total imports of G&J have recorded an unusual rise to)

3.5 GJEPC strong request to devise a prudent solution to safeguard the Sectors under proposed action list including gem and jewellery sector:

As, this is due to the absence of the standard international taxation mechanism for digital global economy and prolonged work by the OECD in this direction , therefore the GJEPC strongly request the Government to have dialogue with the USA for devising a prudent solution to address the concerns of the USA companies while fulfilling the objective of Government of India.

Consensus through dialogues or negotiations over the USA and India concerns would safeguard the various sectors from being adversely affected due to the imposition of the proposed tariffs by the USA which would be an unfair action by the State as the tax challenges posed by the digital economy is not an India versus USA problem, it is a global problem.
