

Sub: Declaration of Results of the Election for Panel Member(s), Regional Chairperson(s) of the Committee of Administration (CoA) of the Gem & Jewellery Export Promotion Council for the year 2025.

Prerequisites of the CoA Election 2025: -

- a) For Diamond Panel MSME category minimum one vote was allowed and maximum two votes were allowed as there were two vacancies and only members registered under the 'Diamond Panel' were eligible to vote.
- b) For Studded Jewellery Panel Status Holder Category maximum one vote was allowed and only members registered under the 'pStudded Jewellery Panel' were eligible to vote.
- c) For SEZ Panel Status Holder Category maximum one vote was allowed and only members registered under the 'SEZ Panel' were eligible to vote.
- d) Based on the membership circular dated 28th March 2025 the panels were allotted to the individual member by the system based on export declaration and the maximum exported product.
- e) Requests for change in mobile number and email ID were received during the CoA Election e-voting period (11th September 2025 to 17th September 2025) however, such requests were not accepted during the voting period, as the notice dated 10th July 2025 had already given members time until 25th July 2025 to update their email ID and mobile number.
- f) Notifications regarding the CoA Election 2025 were published on the GJEPC website and email communications were also sent to all members accordingly
